

CALL FOR NOMINATIONS

Alberta Sports Hall of Fame (ASHF) is seeking nominations to fill a volunteer Board position with an individual that is interested in serving as a Director of the ASHF.

The Alberta Sports Hall of Fame recognizes the builders and champions of sport, celebrating their performances and accomplishments. ASHF represents all groups from men and women to adaptive sports athletes, members of Indigenous groups and the LGBTQ communities who have represented their communities, both Alberta and Canada on the world stage. Because sport is so much more than just physical activity, the ASHF's long-term objective is the preservation, enrichment and development of individuals, community, and sport. The Alberta Sports Hall of Fame is a non-profit organization with a strong belief in celebrating and preserving Alberta's sports history.

The ASHF Board of Directors is a governance board; this requires that Board members have expertise relevant to governance. Governance excellence requires members who can think conceptually and with a long-term perspective, and who are able to welcome a wide range of opinions. The Nominating Committee is seeking nominations of candidates to join this dynamic group of leaders.

The Nominating Committee encourages nominees from different sectors and with diverse backgrounds representing the citizens of Alberta. The Nominating Committee is seeking nominees who are working in a range of roles (e.g., strategic business development, government relations, legal, finance, fund development, revenue generation, communications, technology, change management, social media) all with a passion for sport and knowledge and interest in the ASHF.

Directors are expected to commit the necessary time and expertise required to perform Board and Committee responsibilities. Your volunteer commitment will be a minimum of five (5) Board meetings per year (3 hours each), committee work and 2-3 conference calls (1 hour each).

Interested individuals are required to complete the ASHFM Board nomination form. The deadline is **April 21, 2023.**

ASHFM Board Overview

On a regular basis the Alberta Sports Hall of Fame seeks "expressions of interest" from individuals interested in serving on the ASHF Board of Directors. The volunteer Board of Directors is elected to offer forward guidance and oversee the activities of the ASHF. The Board's activities are determined by the powers, duties, and responsibilities delegated to it as detailed in the ASHF Bylaws. ASHF has a strategic Board with a skills matrix approach to seeking new Board members. The Board, in composite, must have a range of skills, knowledge and attributes. Diversity, inclusion, and advocacy for sport are important selection factors as well as representation from the province of Alberta.

A strong interest and good knowledge of Alberta's sports or affiliation with a sport organization and/or not for profit Board experience is desirable.

The members of the ASHF Board of Directors consists of an active 12 persons that geographically represent the province of Alberta, who graciously devote their time and energy to sport history and engagement in Alberta. Directors come from all walks of life; they are active community members who are passionate about the preservation and evolution of sport.

ASHF Board members must have a clear understanding of, and competence to deal with, the current and emerging issues of the core business (and related businesses) and can effectively review and challenge the performance of management and exercise independent judgement.
